## 2. Presentation of the Host City

Sharm El-Sheikh is an Egyptian city on the southern tip of the Sinai Peninsula, in South Sinai Governorate, on the coastal strip along the Red Sea. Sharm El Sheikh is the administrative hub of Egypt's South Sinai Governorate, which includes the smaller coastal towns of Dahab and Nuweiba as well as the mountainous interior, St. Catherine and Mount Sinai. The city and holiday resort is a significant centre for tourism in Egypt, while also attracting many international conferences and diplomatic meetings. It is also known as the "City of Peace", referring to the large number of International Peace Conferences that have been held there.

### 3. Presentation of the Competition Venue

The competition will take place at the **Swimming Pool of Youth & Sports City**

The venue has a seating capacity of 1800 spectators and features a fully compliant field of play, with all specifications, conditions, and flooring meeting the required standards. The competition pool measures 50 m × 25 m, with a depth of 2 meters and 10 swimming lanes, and is fully homologated for official competitions. The facility is equipped with an ALGE timing and scoring system. In addition, the venue meets accessibility requirements, offering accessible entrances, routes, seating, and restrooms, as well as ramps and lifts for pool entry and exit, accessible changing facilities, and professional lifeguarding services.

## 4. General information

The Egyptian Diving and Lifesaving Federation – authorised by CMAS – invites all interested National Federations to participate in the 2026 CMAS World Championship Finswimming Indoor Masters, scheduled to take place on 10-14/04/2026 in Sharm El-Sheikh, Egypt.

### Various and practical information

- The Currency of Egypt is the Egyptian Pound, EGP.
- Electrical current in Egypt is 220V, 50 Hz.

In Egypt, power plugs and sockets (outlets) of type C and type F are used. The standard voltage is 220 V at a frequency of 50 Hz.

### Information about participation

- Only participants with a CMAS License are eligible to compete in the Competition
- All participants should respect the Competition rules, the safety conditions set by the Organisers and CMAS rules and regulations.

- In case a visa is needed, please send the ANNEX 5 to the Local Organising Committee at least two months before the Competition.

### Swimming Pool Events

The CMAS general rules and CMAS Finswimming rules will be applied.

The participants shall register only individually or as persons representing clubs. No swimmer or team may be designated as representing a country, but a label of Federal Team is authorized. Since federal or club teams are not national ones, a club or a federation can present more than one relay team in each age group.

During CMAS Master's competitions and championships, swimmers must swim exclusively in their age group and cannot compete in any other category.

### Master Age Groups

Each athlete is registered for the individual events in his related age category:

30+, 40+, 50+, 60+, 70+ and 80+.

### Disciplines and Distances (Men & Women)

**Surface (SF):** 50, 100, 200, 400, 800 SF

**Apnea (AP):** 50 AP

**Bi Fins (BF):** 50, 100, 200, 400 BF

**Relay:** 4×50 SF Mixed, 4×100 SB Mixed

The maximum number of enrolments for each participant is 6 (six) for individual races.

All members of a masters' relay must belong to the masters' category i.e., be at least 30 years old.

The starting order for mixed relays is man - woman – man – woman.

A master swimmer may participate in only one relay per session.

Withdrawals must be communicated at the latest during the technical meeting. For every (not timely communicated) non-participation in an event during a CMAS Masters Championship the swimmer is not allowed to participate in any remaining event of the competition, individual or relay. In the case of non-participation in a relay, the relays of the club or federation will not be allowed to participate in any remaining relay event of the competition.
